Northside Methodist Preschool provides a limited number of financial aid awards each year to those in need. Various fundraising events and gifts fund the annual financial aid awards. Due to the number of financial aid applications submitted, only children who are enrolled in a 3-year-old class or older may apply for and be granted aid. Preference will be given to currently enrolled families. Financial aid decisions are not made until after a student has been accepted.

Financial need is defined as the difference between what it costs to attend NMP and your family's ability to pay. Major factors in determining financial need include, but are not limited to, net income, the number of dependents, and the number of children attending tuition-charging schools. Northside Methodist Preschool requires families receiving financial aid to re-apply each year.

Each application must include a copy of the applicant's most recent tax return and W-2s from the past three years. Applications submitted without this information will not be considered.

All information related to the parents' financial position will be treated as confidential. No use will be made of this information and these forms except to arrive at a fair determination of financial aid and will be shredded after a decision is made. The application will be anonymous once the applications are given to the Financial Aid Committee.

Applications for Financial Aid are available on the school website or from Paige Hill, Finance Director. Applications are due to Ms. Hill by February 28, 2017. Decisions will be made by March 31, 2017.
